- Preferred Partners must adhere to federal, state, and local laws and possess the appropriate licenses for advertised categories.
- Encore at Eastmark may inactivate a Preferred Partner if their annual membership fees are not paid by the expiration date.
- Encore at Eastmark may terminate any agreement with a Preferred Partner at any time without a refund of fees. If a Preferred Partner terminates their contract, no refunds will be issued.
